The concept of universal human values might differ from person to person, especially when analyzed based on the background of ancestral roots, communitybased cultural practices, and spiritually based notions. Ruzmatovich (2023) categorized the term 'Universal Value' as a philosophical or axiological concept utilized to indicate the moral principles of things, events, and activities that are most valuable and significant for the human race, "the concept of universal values is a general form of values that are important for the whole society, reflecting the existence, past, present and future of mankind, the main directions of its existence, laws, requirements, and procedures ancient hopes and ideals of people." (p. 796) Values can be divided into two categories: national and universal- under national values- language, culture, identity, tradition, and customs are examined, whereas under universal values- peace, fraternity, labor, science, and literature are inspected. Thus, even though social performances vary from person to person, basic human empathy, integrity, and mutual respect are the true essence of universal human values. But with the transition of time period or the alteration of the lifestyle trends in human being's day to day living, the basic essence of human values are getting deteriorated and misused. Human beings are ignorant of the value education that they need to thoroughly intake in their routinized practices. The natural tendency of soft skills and empathetic behavior in human's internal temperament is getting deceased.

Among all glorified souls, one such saint was Thiruvalluvar from Tamil Nadu, South India, who penned down a masterpiece of human ideals, *Tirukkural*. (Narayana 2015) The Kural text is an ancient system of Indian epistemology and metaphysics. The text holds traditional cultural values of Tamil ancestral roots. It highlights virtues such as truthfulness, self-restraint, gratitude, kindness, and hospitality.

Values are the guiding principle in a person's life that sums up the overall individual's growth. According to Swami Vivekananda, "Every man's character is the sum total of his tendencies, the bent of his intellect." (Chandra, 2022, p.71) But in the age of digitalization, human beings' dependency on social media tools has resulted in havoc, especially in deleting humanity and humility in a human's intramural character. Although social media has given humans access to freedom and speech and quicker connectivity to the human world:

However, problems arise when freedom of speech is used beyond its limits-resulting in the communication of hate speech as a means of expressing feelings of anger, hostility, frustration, and hatred. Social media becomes the most effective and dangerous tool for disseminating such speech". (Nor, 2018, p. 278)

As per the latest research, a post, reel, or video shared on any social networking site reaches people much faster than the traditional media structures. Social media is affecting adolescents' introspection towards self and interpersonal relationships due to social comparisons and negative interactions. According to Singh et al., after a field study, "94% of youth opined that social media is used to spread misinformation and rumors and responsible for increasing cybercrimes among young people like blackmailing, sexual harassment with their unknown friends through chatting." (p.3) The lessons of the Bhagwad Gita emphasize the concept of karma and dharma to direct people to achieve moral fulfillment and virtuous behavior. The Gita stresses the importance of performing duties with a sense of complete detachment from the resulting outcomes. (Mishra, 2024, p.195) Lord Krishna mentors Arjuna to deviate from the materialistic and sensual world in order to gain spiritual morality and restore the calmness of the mind. Maintaining equality, stability of mind, and concentration in work are the prime teachings of Lord Krishna. Unlike older ages, the issue of gender equality is in a much better phase in the twentyfirst century, but still, the perceptivity between the two genders is hugely lacking, and

Women are demarcated and have limited access to resources and decision-making. But society should alter these perspectives and delete discrimination policies for gender, "sensitization of gender is about changing behavior and installing empathy into the view that we hold about our own and the other gender. It assists people in holding their personal point of view and opinion and questioning the actualities they believed they know". (Parekh, 2022, p.49) Schools, colleges, and universities should be in the process of introducing more courses on gender sensitization and universal human values so that, from scratch, students will learn the need to grow empathy in their behaviors. According to Yadav and Ojha (2024), "Gender sensitization is an important part of creating a more fair and inclusive society. It entails increasing knowledge, comprehension, and empathy for different experience issues and identities associated with gender." (p.134) Societies should realize their potential and get closer to sustainable development by investing in women's academic, healthcare, and career prospects. Swami Vivekananda draws a line where he equates the status of both men and women, "In India, the mother is the center of the family and our highest ideal. She is to us the representative of God, as God is the mother of the Universe. It was the female sage who first found the unity of God, as God is the mother of the Universe." (Bansal, 2015, p.85) Swami Vivekananda stressed the importance of respecting females in our society who always embrace an inferiority complex in terms of respect and dignity. And this mark of losing honor and life for women can best be recalled with the recent gruesome gang rape and murder case of a 31-year-old trainee postgraduate doctor at RG Kar Medical College and Hospital at Kolkata Hospital. In India, no matter how strict laws are implemented for women, they are not safe and secure starting from the age of three to eighty years; women are always undergoing stress and fear. The nation that worships Durga, Lakshmi, and Saraswati is the same nation that rapes and maltreats women.

But again, the discrimination of gender, especially in the case of men, can best be described with the shocking incident of the suicide of Atul Subhash, the AI engineer from Bangalore. Atul's suicidal note stressed the burden and stress that a man has to face in this society. When choosing money and power, humanity is erased or lost from the human beings. As per the allegations raised by the victim, her Wife instigated him suicide, and his Wife ruthlessly replied to a message, "...Everything owned by the husband belongs to the wife. After you die, your parents will die soon. The daughter-in-law has her share. Your whole family will make the rounds of court." (Bose 2024) The human blood and soul had probably dried up in Nikita Singhania's

Our society should immediately encourage women to exercise weightlifting, self-dependency, and economic responsibilities, and at the same time, it should teach men kitchen-based practices and domicile activities so that the discrimination or differences between men and women are erased from society.
